4. 2:15 – 3:10 Discuss/Vote on Subcommittee's Draft Bylaw Revisions

Facilitators: Dr. McClain Watson and Jonathan Stewart

- Bylaw Committee has been working over the summer
- Big changes include:
 - 2.4b—Updated section on the job requirements of *The Mercury's* Editor-in-Chief and Radio UTD's Station Manager
 - They are allowed to hold off-campus jobs
 - If they do, it needs to be reported
 - Strongly discouraged
 - This change helps avoid a conflict of interest
 - Organizations were better equipped to handle the conflict of interest rather than the restriction in the bylaws
 - Need to verify hours allowed to work for graduate students
 - o 4.6—New appeal process
 - o Structure, defined timelines, etc.
 - Defined procedure for bylaw exceptions—COSM can make a change to the bylaws
- 2.1a—Remove "other student media, which may, from time to time, be funded from student fees"
- 2.1k—What does it take to have quorum?
 - o Past meetings have been canceled due to lack of attendees
 - Can't be too particular on what justifies quorum
- 2.3a, 2.4a, 2.5a, 2.6a—How and when are grades verified?
 - Student Media's Administrative Assistant II will verify when the candidate is being considered
- 2.3f, 2.4g, 2.5f, 2.6f—If they have been removed from office by COSM they are not eligible to re-apply
- 2.4d—Concerning *Mercury* 's Editor-in-Chief
- 4.2z—What does COSM want done with the materials that are in the kiosks if they're not affiliated with Student Media?
- 4.5—If there is a Student Media leader being removed, only voting members are allowed to attend the COSM meetings
 - Others may be invited for testimony purposes
- 4.5c—COSM is the appeal body, not the removal
 - o Each leader makes their personnel decisions

- 4.3i—Change AI to Artificial Intelligence
 - O Vague wording in the bylaw—stronger language concerning distinguishing texts from images, being explicit on *how* AI is exposed
